The Appeals Commission, established by the Rector's Order No. 2.01.-04/5 of Turība University on July 4, 2025, having reviewed the application of students:

- [..] the application (registered on July 3, 2025, No. 1601),
- [..] the application (registered on July 3, 2025, No. 1600),
- [..] the application (registered on July 2, 2025, No. 1591),
- [..] the application (registered on July 2, 2025, No. 1589),
- [..] the application (registered on July 2, 2025, No. 1585),

has made the following decisions:

- 1. [...] (contract No. 99939) the appeal is upheld; the average grade is recalculated in accordance with clause 14.1 of the Tuition Fee Discount Rotation Regulations for the academic year 2024/2025;
- 2. [..] (contract No. 99247) the appeal is upheld; the average grade is recalculated in accordance with clause 14.1 of the Tuition Fee Discount Rotation Regulations for the academic year 2024/2025;
- 3. [..] (contract No. 100182) the appeal is upheld; the average grade is recalculated in accordance with clause 19.2 of the Tuition Fee Discount Rotation Regulations for the academic year 2024/2025;
- 4. [..] (contract No. 102699) the appeal is rejected in accordance with clause 14.1 of the Tuition Fee Discount Rotation Regulations for the 2024/2025 academic year; the student retains the place on the list of Budget places and scholarships for the academic year 2025/2026;

- 5. [..] (contract No. 102473) the appeal is rejected in accordance with clause 20 of the Tuition Fee Discount Rotation Regulations for the 2024/2025 academic year; the student retains the place on the list of Budget places and scholarships for the academic year 2025/2026;
- 6. [..] (contract No. 104796) the appeal is rejected. According to clause 2.1 of the Tuition Fee Discount Application Regulations for the academic year 2024/2025, there is no eligibility to apply for budget-funded places or scholarships. Master's students may apply for the "Academic Performance" discount, whereas in accordance with clause 14.2 of the Tuition Fee Discount Rotation Regulations for the academic year 2024/2025, there are no grades that would qualify for inclusion in the list.
- 7. [..] (contract No. 106977) the appeal is rejected. According to clause 1.5 of the Tuition Fee Discount Application Regulations for the academic year 2024/2025, there is no eligibility to apply for the "Academic Performance" discount, in addition, according to clause 2.1 of the same regulations, there is no eligibility to apply for budget-funded places or scholarships.
