

# PhD Position in Sociology of Authoritarian Law – Politics of Anti-Corruption Turība University, Faculty of Law

## Description of the workplace

## **Project description**

This project investigates how international anti-corruption frameworks are interpreted and applied in Central Asia's authoritarian legal systems. The research will unpack how global norms - rooted in Western legal traditions - are adapted, contested, or resisted by domestic institutions shaped by collectivist values and legal nihilism. The doctoral candidate will engage in fieldwork examining the implementation and local meaning of anti-corruption practices and agencies.

### Tasks and responsibilities

As a doctoral student, you will be admitted to doctoral studies of public law and employed at Turība University.

#### You will:

- Conduct independent research within the scope of the project.
- Participate in training events, workshops, and conferences organized by the SOCIAL Doctoral Network.
- Undertake fieldwork in Central Asia and two mandatory secondments (one academic, one non-academic) abroad
- Collaborate with international supervisors and peers.
- Contribute to Faculty activities, including teaching and seminars.

# **Doctoral Programme of Law**

The doctoral program in law science provides an opportunity to acquire in-depth competencies necessary for independent research work and its completion with original and empirically proven results. Graduates of the program can become law researchers who are focused on the European market and ready to compete internationally.

Within the framework of the doctoral study program, it is possible to improve the ability to analyze problems in the theory of law, sociology and the history of law, to solve topical issues in the selected

fields of law, to implement and develop bachelor and master study programs, as well as to develop skills in academic work and study scientific research methods.

The working language is English. The doctoral program in law science comprises 180 ECTS (equivalent to three years of full-time study).

# **General Requirements**

- Excellent ability to express yourself in spoken and written English.
- Strong motivation and ability to work independently under pressure.
- Good collaboration and communication skills.

During the admission process, the applicant's research proposal on the topicality of his / her doctoral thesis (focus on the topic "The Politics of fight against corruption: examine local adoption and manipulation of international anti-corruption standards") and the relevance of the previously acquired master's or professional master's diploma to the field of law is evaluated. The research proposal, as well as previous theses and published material in Law are important documents for assessing this ability.

Applicant is required to provide one of the English language certificates mentioned within the admission information. If the applicant does not have any of the respective English language certificates, however the medium of instruction of his/her master studies was English, he/she will receive a link to Turība University on-line English test after the registration.

## **Specific Requirements**

- A completed degree at the master level in Law.
- Doctoral candidates cannot have been awarded a doctoral degree and/or completed more than four years of full-time equivalent research experience.
- In line with the eligibility criteria and on Marie Skłodowska-Curie Actions Doctoral Networks programme, doctoral candidates must not have resided or carried out their main activity (i.e. work, studies) in the hosting country for more than 12 months in the 3 years immediately before the recruitment date. ### Application procedure

1. #### Before starting the on-line application procedure, please, prepare the following documents:

- A motivation letter in English (max 1,000 words), including a brief presentation of yourself and your qualifications, as well as a short description of why you are interested in the doctoral program in Law at Turība University, PhD Position in Sociology of Authoritarian Law DC4 Politics of Anti-Corruption.
- A copy of the Master's degree certificate with a transcript in the original language and an official translation to English or Russian.
- Research proposal for doctoral thesis on the topic "The Politics of fight against corruption: examining local adoption and manipulation of international anti-corruption standards". The proposal should be no more than 13,000 characters (including spaces and references) and written in English. Please ensure that your proposed research aligns closely with the focus of the PhD project, Sociology of Authoritarian Law Politics of Anti-Corruption. A research proposal must include annotation, the relevance of the research, research problems and their description, the aim and tasks of the research, the hypothesis of the research, analysis of the main sources used in the research, expected scientific and practical results.

- <u>Motivation letter</u> and <u>Research proposal</u> should be combined in one pdf document and submitted together under section "Research proposal".
- English language certificate if you have such certificate (please see below on the Accepted ones).
- Curriculum Vitae (CV) in English demonstrating eligibility for doctoral studies in Law. Please include in CV Names and contact details of two referees.
- A copy of the passport.
- One photo.
- 2. The applicants will be assessed based on the above general and specific requirements, and topranked candidates will be invited for an interview.
- 3. The applicants are requested to pass online interview on Cisco Webex platform and the education document copies are submitted for the verification. Applicants will be required to pass video online interview on Cisco Webex platform. During the interview, excellent ability to express oneself in speech and writing is of great importance. As doctoral studies in Law are highly demanding, the candidate must be strongly motivated.

A writing sample (e.g., a master's thesis or a published paper) demonstrating the applicant's research and writing skills, as well as any other supporting documents, may be requested from the applicant after the interview.

- 4. After positive online interview, applicants' education document copies will be submitted to the Academic Information Centre for verification. This procedure can take up to 4 weeks.
- 5. Applicants will be requested to send notarized copies of all your education documents (secondary education, Bachelor's and Master's degree certificates with transcripts) via courier service or the regular mail to the Turība University.
- 6. After we have received an approval of your education documents from the Academic Information Centre, applicant will be required to send all the notarized education document copies to the University. Afterwards a study agreement will be prepared and sent to the applicant. The agreement will have to be signed and couriered back to the University.
- \*We require minimum score of 60% for the last obtained applicable education.
